### 427.12.19 SUPPORT FOR VÉLO PAYS-D'EN-HAUT'S REQUEST FOR FINANCING TO THE QUEBEC GOVERNMENT

CONSIDERING Vélo Pays-d'en-Haut's request for support regarding their financing request to the Quebec government aimed at upgrading certain mountain bike trails;

It is proposed by Councillor Leigh MacLeod

#### IT IS RESOLVED:

TO AUTHORIZE the presentation of a VPDH-SMH mountain bike trail project to the Ministry of Education and Higher Education within the support program for the upgrading and improvement of trails and outdoor activity sites which implicates as follows:

- the upgrading of approximately 13 km of existing trails (alpine ski, cross-country ski, snowshoe and bike), situé sur les propriétés de Sommet Morin Heights, de la Municipalité de Morin-Heights et de la MRC des Paysd'en-Haut, afin de pouvoir y faire du vélo de montagne l'été, voir annexe 1 croquis préliminaire et annexe 2 budget préliminaire;
- the grant, combined with the amount invested by the Municipality, allows us to request up to \$ 150,000 (80% of the cost of the work), in order to undertake a project worth \$ 187,500, the Municipality agrees to invest an amount of \$ 2 000 in 2020 (the grant request is in the amount of \$ 148,000).
- $_{\odot}$  the balance of costs of the work of 20%, specifically \$ 37,500 will be paid for by:
- Sommet Morin Heights (SMH) for an amount of \$ 17,000;
- Club de Vélo Pays d'en Haut (VPDH) for an amount of \$ 20,500 for which a request for sponsors is underway. If this amount is not completely covered by one or many sponsors, a loan may be obtained and financed by the Comité sentiers VPDH-SMH « fund »;
- O Sommet Morin-Heights, the Municipality of Morin-Heights and the MRC des Pays-d'en- Haut must transfer the right-of-ways for the 13 km of trails and upgrade them, to VPDH for a period of 5 years to be renewed annually, the draft agreement is attached herewith as Annex 3;
- o From 2020 to 2024, VPDH agrees to:
- preserve the Municipality of Morin-Heights as the main training location, but not exclusive;
- preserve the Municipality of Morin-Heights as a site for regional races;
- to take steps in order to organize the Quebec mountain bike Cup in Morin-Heights.

TO CONFIRM the Municipality's commitment to pay its share of admissible costs of the project and pay its share of continued operating costs;

- share of admissible costs of \$ 2,000 for the construction of phase 1 provided for in 2020.
- share of continued operating costs from 2020 to 2024 (5 years) paid by the Municipality of Morin-Heights is the civil liability insurance coverage of \$ 2 000,000 covering the club Vélo Pays-d'en-Haut, Sommet Morin Heights and the Municipality of Morin-Heights for activities on the bike trails.
