TO ADOPT By-law (595-2020) which modifies By-law (577-2019) regarding financial administration in order to update certain provisions regarding the director general's delegations of power as follows:

By-law 595 -2020

which modifies By-law (577-2019) regarding financial administration in order to update certain provisions regarding the director general's delegations of power

EXPLANATORY NOTE

The present by-law modifies By-law (577-2019) regarding financial administration in order to regulate tacit delegations assumed by the Director general, either pertaining to the presentation of an employer's grievance or regarding Article 109.2 of the Act respecting Land use planning and Development (RLRQ. ch. A-19.1) to determine dates for public consultations without having to adopt a resolution.

It also delegates the Director general the power to grant a contract for the issuance of goods pursuant to the holding of a request for tenders as per Article 1065 of the Municipal Code.

WHEREAS Articles 212.1, 960.1 and 961.1 of the Municipal Code of Québec regarding the regulations for budgetary control and follow-ups, the delegations of power and pertinent accountability;

CONSIDERING THAT as per Article 961 of the Municipal Code of Québec, Council's by-law or resolution which authorizes an expense may only come into effect if, in accordance to the by-law adopted as per the second paragraph of Article 960.1, credits are available for the purpose for which the expenses is projected;

CONSIDERING THAT as per the fourth paragraph of Article 961.1 of the Municipal Code of Québec, an authorization of expenses granted as per a delegation may only come into effect if, in accordance to the by-law adopted as per the second paragraph of Article 960.1, credits are available for this purpose;

WHEREAS THAT the Director general presents, from time to time and whenever necessary, grievances in the Municipality's name as per the collective agreements in effect;

CONSIDERING Article 119.2 of the Act respecting Land use planning and Development (RLRQ., ch. A-19.1);

WHEREAS THAT a notice of motion was given by Councillor Claude P. Lemire at the regular Council meeting of May 13th, 2020 and that this draft by-law was presented;

CONSEQUENTLY, the municipal council decrees the following:

CHAPTER 1: INTRODUCTORY PROVISIONS

1. **Goal** – The goal of the present by-law is to regulate two existing situations regarding delegations actually assumed by the Director general in these cases.

2. **Objective** – The provisions of the by-law must be interpreted in such a way as to allow for an efficient administration of public funds despite the increase in the municipal administration's activities.

CHAPTER 2: AMENDING PROVISIONS

- 3. **New delegations** The by-law is modified with the addition, after Article 40, of the following articles:
- « 40.1 **Presentation of an employer's grievance** Council delegates to the Director general, the power to present any of the employer's grievances necessary and in compliance to the provisions of the Quebec Labour Code (RLRQ., ch. C-27).
- 40.2 **Determination of dates for public consultations** Council delegates the Director general, in accordance to Article 109.2 of the Act respecting Land use and Development (RLRQ., ch. A-19.1), the power to determine the dates of public consultations held as per said Act.
- 40.3 **Contract for the issuance of goods** Council delegates the Director general, in accordance to Article 1066.1 of the Municipal Code (RLRQ., ch. C27.1), the power to grant any contract to the person who has the right, following a request for tender held by the Minister of Finance or the Municipality as per Article 1065 of this Act.»

The Director general gives a summary of the by-law and informs Council about the adoption procedure.

It is proposed by Councillor Jean Dutil And unanimously resolved by all councillors:

TO ADOPT By-law (592-2020) providing for financing for the repairs to a section of Watchorn road and decree of a loan for this purpose as follows:

By-law 592-2020

providing for financing for the repairs to a section of Watchorn road and decree of a loan for this purpose

WHEREAS the terms of the Quebec government's new FIMEAU infrastructure program;

CONSIDERING the Municipal works Act;

CONSIDERING the Act respecting municipal loans and debts;

CONSIDERING Articles 1060.1 and following of the Municipal Code;

WHEREAS THAT the repairs to Watchorn road between Village road and Route 364 is a priority for the 2020-2021-2022 capital triennial program;

CONSIDERING THAT a notice of motion of this by-law was beforehand given by Councillor Jean Dutil at the Council meeting of May 13th, 2020;

CONSIDERING THAT the draft by-law was presented at the Council meeting of May 13th, 2020;

CONSIDERING THAT all of the members in attendance declare having read the draft by-law and that they renounce to its reading;

CONSIDERING THAT the Director general and secretary-treasurer specifies that this by-law pertains to obtaining financing for the repairs to a section of Watchorn road and decree of a loan for this purpose;

CONSEQUENTLY, the municipal council decrees the following:

- 1. **Work authorization** Work is authorized for the repairs to infrastructures on Watchorn road between Village road and Route 364 including professional fees and other pertinent costs for a total amount of 3,040 million dollars (\$3,040,000) as shown on the estimate prepared by the Director general and Régis Doré, engineer on the April 20th, 2020 attached herewith as Annex A.
- 2. **Expense authorization** An expense of 3,040 million dollars (\$ 3,040,000) is authorized for the purpose of this by-law.
- 3. **Loan authorization** For the purpose of paying for the expenses stipulated in the present by-law, Council is authorized to borrow an amount of \$ 3,040,000 reimbursable over a period of 20 years.
- 4. **Allocation to the reduction of the loan** Council allocates to the reduction of the loan decreed by the present by-law, the entire grant received as per the PRIMEAU or any other governmental infrastructure financing program, up to the limits specified by said program.
- 5. **Use of surplus –** Should an allocated amount authorized by the present By-law be higher than the amount actually spent in regard to this allocation, Council is authorized to use this surplus to pay for any expense decreed by the present by-law and for which the allocation is deemed insufficient.

- 6. **Special tax** In order to provide for 75% of expenses incurred pertaining to interests and the reimbursement in capital at the loan's annual due dates, a special tax will be imposed at a sufficient rate by the present bylaw and will be levied annually during the term of the loan on all of the taxable properties on the Municipality's territory as per the value shown on the evaluation roll in effect each year.
- 7. **Sector tax** In order to provide for 25% of expenses incurred pertaining to interests and the reimbursement in capital at the loan's annual due dates, a special tax will be imposed at a sufficient rate by the present bylaw and will be levied annually during the term of the loan on all of the taxable properties located on Watchorn road between Village road and Route 364, as per the value shown on the evaluation roll in effect each year.
- 8. **Entering into effect** The present by-law enters into effect in accordance to the Law but conditional to having obtained financing from one of the programs specified in Article 4.

CHAPTER 1: INTRODUCTORY PROVISIONS

- 1. **Goal** The goal of the present by-law is to follow-up with the municipal Council's position to protect the architectural integrity by imposing development regulations for zone 38 by including it into the existing regulations.
- 2. **Objective** The provisions of the by-law must be interpreted in order for every future request for construction or renovation permit or any other permit or certificate stipulated in By-law (420) regarding PIIA be submitted to the existing regulations regarding architectural development and integration plans, including those implicating the Planning advisory committee.

CHAPTER 2: AMENDING PROVISION

3. **Inclusion of zone 38** – Article 19 of the by-law is modified in order to include zone 38.

CHAPTER 3: FINAL PROVISION

4. **Entering into effect -** The present by-law enters into effect according to the Act respecting land use and development (RLRQ., ch. A-19.1).
